1. All retreat attendees agree to abide by the rules, regulations and policies set forth by Camp Kodiak Inc. (the Camp)
2. The Camp reserves the right to dismiss any individual, without refund, whose conduct or influence it deems to be unsatisfactory or harmful to the best interests of the individual, other attendees or the Camp. It is acknowledged that the program operating on the Camp Kodiak site will be operating as a rental facility this summer and will not provide personnel to support the needs of attendees, nor is it a respite facility.
3. There are inherent risks associated with attending an overnight family retreat and participating in outdoor recreational activities activities. Every measure will be taken to ensure the health and safety of each attendee. In the event of sickness or accident, however, the Camp, its officers and employees shall not be held liable beyond the limits of insurance coverage.  Initial Here  
All claims and/or litigation shall take place under the laws and jurisdiction of the Province of Ontario.
4. The Camp shall make no financial allowances for the late arrival, early departure, or any absence by attendees. Those who need to leave early or arrive late because of COVID-19 symptoms will be able to have their costs prorated at the discretion of the Camp Directors.
5. Attendees may cancel a retreat booking up to fourteen (14) days prior to their scheduled arrival for a full refund. Any cancellations less than fourteen (14) days prior to the arrival date will not be refunded.
6. While every effort will be made to return lost, misplaced or stolen property, the Camp shall not be held liable for these articles. Nor shall it be held liable for broken or damaged property.
7. The Camp has the right to use photographs and videotape of attendees in its promotional material.
8. The Camp reserves the right to cancel this contract without penalty by written notice to the person or organization responsible for the payment of fees.
9. Neither the Camp nor the person or organization responsible for the payment of fees shall be held accountable or penalized under the terms of this agreement for failure to perform which is occasioned by war, strike, pandemic, public health emergency, act of God, natural disaster, or other casualty beyond reasonable control of either Party.
10. The Camp has the right to share information regarding attendees with members of the Camp Kodiak staff.
11. This document shall serve as the only contract between the parties and supercedes all other verbal or written contracts between parties, and contains herein all terms and conditions.
12. The proper law of this contract is that of Ontario, Canada.

## IMPORTANT INFORMATION REGARDING COVID-19

**The Camp will take all necessary precautions to prevent the spread of COVID-19 at camp, but the Camp will not be responsible if an attendee contracts COVID-19 while at camp or as a result of having attended a family retreat at Camp Kodiak. Any individual who exhibits symptoms of COVID-19 will be asked to leave the Camp immediately. Prorated refunds or retreat rescheduling will be provided at the discretion of Camp Directors.**
